Eligibility Conditions for becoming a member of Society according to Haryana Registration & Regulation of Societies Act, 2012.

16. Eligibility conditions for becoming a member:- A person shall be eligible to become a member of Society if he-
- (i) is 21 years of age on the date of admission.
  - (ii) subscribes to the aims and objects of the Society.
  - (iii) has deposited the membership fee as prescribed in the Bye-laws of the Society and
  - (iv) is not a insolvent or of unsound mind or have not been convicted of an offence involving moral turpitude, punishable with imprisonment of one year or more.
